Production of Shape Durban Videos and Photographs

1. Introduction

The eThekweni Municipality requires a service provider that will be able to undertake work necessary for the EDS shape Durban Conference taking place in 21-23 November 2018. The shape Durban conference is a three day event. The service provider will be required to handle video and photography and related activities.

2. Background Information

In 2013, eThekweni Municipality adopted the Economic Development and Job Creation Strategy for 2013-18. With the past strategy timeline coming to an end, we have started the process of developing the 2019-25 Economic Development strategy and envision completing this work in the next several months.

SHAPE DURBAN is a co-curated, co-branded, co-owned conference for stakeholder inputs to co-created economic development strategy for eThekweni.

The anticipated number of attending delegates will be approximately 400 people made up of businesses, youth, academia, public sector and NGO's.

3. Purpose and Objective of Project

The objective of this project is to produce a video and photographs that are:

- Professional,
- Innovative,
- Appealing; and
- Succinct.

4. Scope of Project

The production of the video and photographs entails:

- 4.1. Full development of the video and photographs.
- 4.2. Length of the video at most 20 minutes and 5 minutes summary
- 4.3. Video to focus on conference themes being discussed
- 4.4. Upload edited video & photos on a website.

4.5. Pictures sized for the social media and original large formats (edited) for quality

4.6. Create a cloud storage (one drive).

Note: The project of the videos and photographs of the conference will consist of all the important sessions of the 3 day conference.

5. Tasks and Duties

The appointed service provider will be required to undertake the following tasks and duties for the successful completion of this project:

5.1. Video recording and photo shooting ,

5.2. Have 3 videos from each day compiled into 1 video.

5.3. Voice in the background

5.4. Corporate music or any other sound effects and

5.5. Delivery of 2 USB containing a video and photos

Note: The service provider is expected to deliver both the video and photos to the PSIR offices at no. 41 Margaret Mncadi Avenue, Durban; 12th Floor Rennies House; by **the 27 November 2018**.

6. Milestones and Timeframes

The project timeframe will be 3 days in duration, **commencing on the 21 November 2018 and ending on the 23 November 2018**.

The time frames for each output will be discussed and agreed upon when awarding the contract.

7. Copyright on Documents

Please note that as a requirement of this project, all output and copyright thereof will become the property of eThekweni Municipality. The material developed under this project shall by no means be used by any other sources. In the event of termination of this appointment, the PSIR Department reserves the right to use all or any parts of the documentation for completion of the project.

8. Project Team Requirements

The project team will be required to possess the following knowledge and/or experience; requirements:

- Minimum of 5 years' experience in video and photography
- Proof of work on similar type and scale of projects
- Registered on the EThekwini Database

(It is imperative that the Curriculum Vitae's of the core staff be provided.)

9. Proposal and Financial Issues

All interested service providers should submit a proposal that displays an understanding of the requirements of the project. The proposal should include (but is not limited to):

- A project plan
- Cost breakdowns per submission
- Timelines (which specifically state how the service provider aims to have the work completed by the **27 November 2018**.)
 - Timeline should include scheduling of each key action listed in section 5 (e.g. when will they be able to provide the final products, and how many calendar days are required for this task?)
 - Timeline is to include two face to face project meetings and possible changes based on client feedback at meetings.

Please note that the appointment will be made in terms of the Council's Procurement Policy.

The following requirements must be adhered to as part of the tendering process:

- The quotation (to be included with the proposal) shall include total cost, VAT and disbursements as separate figures. A schedule of projected time and financial cost per phase, must be provided
- Tax clearance certificate
- (MBD 9) Forms:
 - Original Certificate of Independent Bid Determination
 - Original Declaration of Interest
 - Original Declaration of Municipal Fees
 - Original BBBEE certification

These terms of reference are subject to any changes which may stem from a negotiation of the final terms with the service provider, as well as any additional budget which may be allocated to the project.

Payment arrangements will be negotiated on the basis of the completion of project milestones and will be outlined in the letter of appointment. Final payment will be paid on full completion of the project and the receipt of the final set of deliverables.

The adjudication of this Request for Proposal will be in terms of MFMA Circular 53 (Municipal Finance Management Act No. 56 of 2003), whereby FUNCTIONALITY is included in this bid as a criterion and will be assessed in terms of the evaluation criteria detailed in the table below. Any bid which fails to meet the minimum threshold of 70 out of 100 points for functionality will be disqualified. Thereafter, only qualifying bids will be evaluated in terms of the 80/20 preference points system where 80 points is used for price only and 20 points are used for BEE points.

The adjudication of this Request for Proposal will be in terms of the criteria presented below and be in compliance with the scope, purpose, and methodology of the intervention.

Evaluation Criteria

In terms of amended guidelines in respect of bids that include functionality as a criterion for evaluation, the evaluation of the proposals will be conducted in two stages.



C. CERTIFICATE OF INDEPENDENT BID DETERMINATION

1. This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
2. Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
3. Municipal Supply Regulation 38 (1) prescribes that a supply chain management policy must provide measures for the combating of abuse of the supply chain management system, and must enable the accounting officer, among others, to:
 - a. take all reasonable steps to prevent such abuse;
 - b. reject the bid of any bidder if that bidder or any of its directors has abused the supply chain management system of the municipality or municipal entity or has committed any improper conduct in relation to such system; and
 - c. cancel a contract awarded to a person if the person committed any corrupt or fraudulent act during the bidding process or the execution of the contract.
4. This MBD serves as a certificate of declaration that would be used by institutions to ensure that, when bids are considered, reasonable steps are taken to prevent any form of bid-rigging.
5. In order to give effect to the above, the attached Certificate of Bid Determination (MBD 9) must be completed and submitted with the bid:

² Bid rigging (or collusive bidding) occurs when businesses, that would otherwise be expected to compete, secretly conspire to raise prices or lower the quality of goods and / or services for purchasers who wish to acquire goods and / or services through a bidding process. Bid rigging is, therefore, an agreement between competitors not to compete.

7. In particular, without limiting the generality of paragraphs 6 above, there has been no consultation, communication, agreement or arrangement with any competitor regarding:
 - a) prices;
 - b) geographical area where product or service will be rendered (market allocation)
 - c) methods, factors or formulas used to calculate prices;
 - d) the intention or decision to submit or not to submit, a bid;

- e) the submission of a bid which does not meet the specifications and conditions of the bid;
Or
- f) bidding with the intention not to win the bid.

8. In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications and conditions or delivery particulars of the products or services to which this bid invitation relates.

9. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.

10. I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No. 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No. 12 of 2004 or any other applicable legislation.
