1. Background

2. Purpose of the request for proposal

The Durban ICC requires a service provider for the supply and delivery of male and female formal shirts, jerseys and female camisole.

- Quantities may be subject to change at the time of placing an order.
- The Durban ICC reserves the right to appoint more than one service provider for the provision of these products.
