



**RE-ADVERTISEMENT: REQUEST FOR QUOTATION – BS 24/2018**

**SUPPLY AND FIT FIRE RETARDANT CANVAS CANOPY AT THE DURBAN ICC COFFEE SHOP**

**1. Background**

The Durban ICC is one of the world’s leading events and meetings destinations. In order to maintain the extremely high international standards as a facility it is important that we have the correct infrastructure in the various areas so that our operations run optimally thereby ensuring efficient client service.

**2. Purpose of the request for proposal**

The Durban ICC requires a service provider to supply and fit a fire retardant Canvas Canopy at the Durban ICC coffee shop.

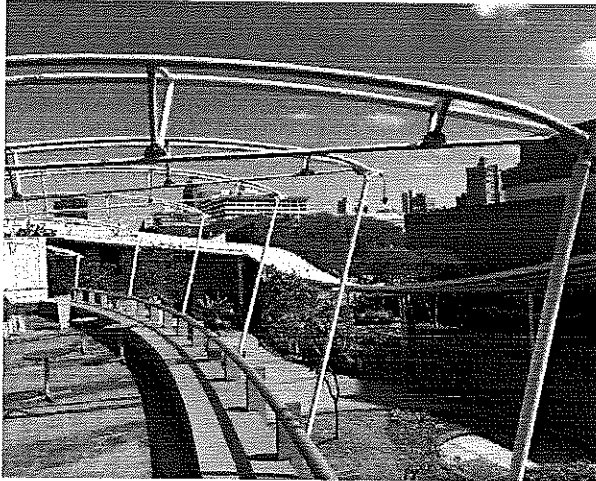

Failure to acknowledge and fulfil the mandatory requirements as illustrated in the schedule above will result in the service provider being deemed non-responsive and not evaluated further.

**4. Conditions of contract:**

- 4.1 The service provider must include all Health and Safety requirements and make provisions to access high level areas. The current height from coffee shop floor to metal structure is approximately 4 metres.
- 4.2 The service provider must have third party liability cover of minimum one million rand or make provisions to acquire such cover should they be awarded the contract.
- 4.3 All material and overheads, such as fixing plates; aluminium extrusion, labour etc. must be supplied and quoted for by the service provider.
- 4.4 The service provider is permitted to submit a detailed pricing schedule, as an addendum, taking all overheads into account, should the compulsory pricing schedule on this bid document not be deemed comprehensive.
- 4.5 There should be no hidden costs and pricing will remain firm without the possibility of escalation.
- 4.6 The actual size of the Canvas will be agreed upon at the compulsory site inspection.

6. Preconditions

A written proposal/quotation will not be considered unless the service provider who submits the quotation provides the following with their proposal/quotation:

- 6.1 Full name.
- 6.2 Identification or company or other registration number.
- 6.3 Tax reference number and VAT number, if any.
- 6.4 Valid original Tax Clearance Certificate from the South African Revenue Services which proves that the service provider's tax matters are in order.
- 6.5 Valid BBBEE Certificate.
- 6.6 MBD 4 Declaration of Interest form must be completed.
- 6.7 Statement that the company's water, electricity and rates are up to date or formal payment arrangements have been made.
- 6.8 The service provider must be registered on the CSD database and EThekweni Vendor Portal. Proof of registration needs to be submitted. Failure to be registered on these databases will adversely affect the awarding process and may result in the service provider being deemed non-responsive.




